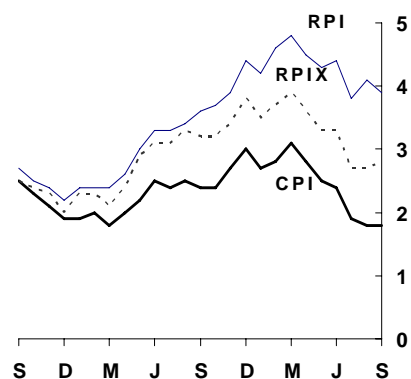

Consumer price indices September 2007

In the year to September, the consumer prices index (CPI) rose by 1.8 per cent, unchanged from August.

In the year to September, the all items retail prices index (RPI) rose by 3.9 per cent, down from 4.1 per cent in August.

Over the same period, the all items RPI excluding mortgage interest payments (RPIX) rose by 2.8 per cent, up from 2.7 per cent in August.

Main contributions to the change in the 12-month rate¹

CPI

The largest downward contribution to the change in the CPI annual rate came from housing and household services. This was due to gas and electricity bills which both fell as a result of the continued phasing in of recent tariff reductions. Over the same period last year, average gas and electricity bills rose. A partially offsetting upward effect came from liquid fuels, which rose in price in September but fell a year ago.

Another large downward effect came from clothing and footwear, as prices rose by less than last September, especially for men's outerwear. In particular, prices for winter coats fell this year compared with sharp increases a year ago.

A small downward effect came from communication, mainly due to telephones and related services, where handsets for both landlines and mobiles fell in price in September, in contrast to rises last year.

The largest upward effect on the CPI annual rate came from food and non-alcoholic beverages, mainly due to rising prices for dairy products, specifically:

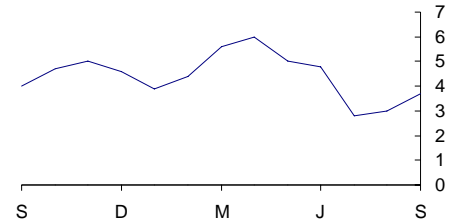
- Milk, cheese and eggs, where prices overall rose by 6 per cent in September. This was largely due to widely publicised price increases for shop bought milk, the average price of which increased by 4 pence a pint between August and September. Increases were particularly commonplace at supermarkets. There was also a small upward effect from cheese; and
- Oils and fats, where average prices for both margarine and butter increased in September by over 15 per cent.

A large, partially offsetting downward effect came from vegetables, due to changes in the prices of winter vegetables and tomatoes. There was also a small downward effect from mineral waters, soft drinks and juices, where prices fell in September but rose a year ago.

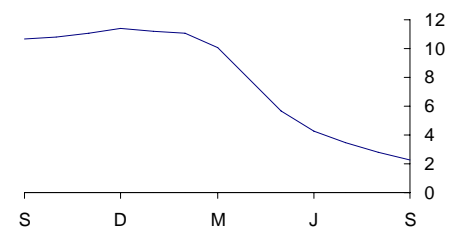
A small upward contribution to the change in the CPI annual rate came from furniture and household goods, where prices for furniture and furnishings rose by more than a year ago.

Although transport had little effect on the change in the CPI annual rate, within the division, a large upward effect came from petrol and oil. Petrol pump prices fell by around 1 pence per litre in September, compared with a fall of over 6 pence per litre a year ago. This was offset by large downward contributions from both air and sea fares, where seasonal reductions, on European routes especially, were greater than last September.

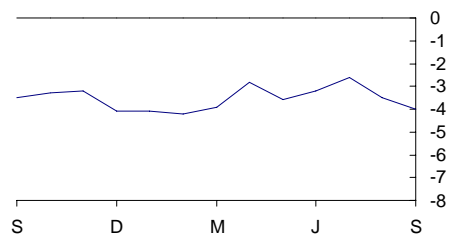
Food & non-alcoholic drinks

RPI

The largest downward contribution to the change in the RPI annual rate came from housing, due to mortgage interest payments. Mortgage interest rates were largely unchanged in September but rose a year ago, when most lenders passed on the quarter point rise in the Bank of England Bank rate announced in August 2006. Mortgage interest payments are excluded from the CPI.

Further large downward effects came from:

- Fares and other travel costs, where, as in the CPI, the seasonal fall in air and sea fares was greater than last September, especially for travel to European destinations; and
- Fuel and light, where average gas and electricity bills fell this year but rose a year ago.

Small downward effects came from:

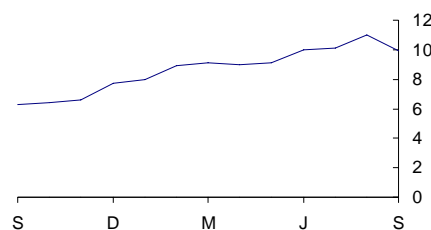
- Clothing and footwear, where prices rose in September by less than last year, particularly for men's outerwear; and
- Leisure goods, mainly due to prices for audio-visual goods, which fell in September but showed little change a year ago.

The largest upward contribution to the change in the RPI annual rate came from motoring expenditure. The average decrease in petrol prices recorded in September was much smaller than a year ago, when the average price for a litre of petrol fell by 6.4 pence.

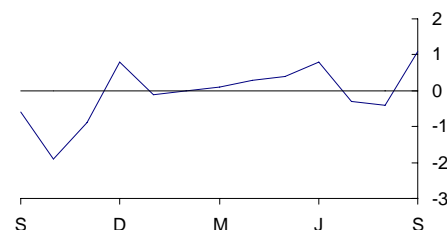
As in the CPI, a large upward effect came from food, mainly due to increased milk and butter prices at supermarkets. Partially offsetting downward contributions came from soft drinks and fresh vegetables, with prices for both falling in September but rising a year ago.

A small upward effect on the change in the RPI annual rate came from household goods, due to larger price increases on a range of furniture items compared with last September.

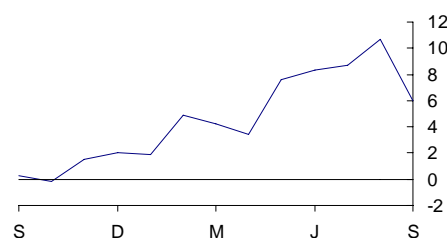
Housing
RPI percentage changes over 12 months



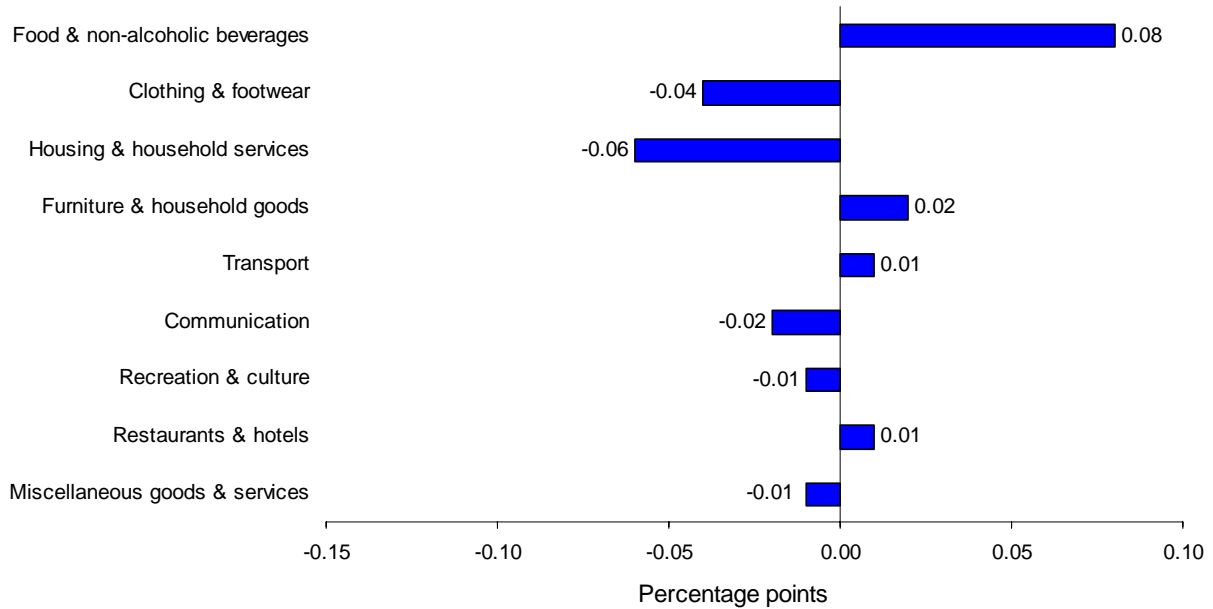
Motoring expenditure
RPI percentage changes over 12 months



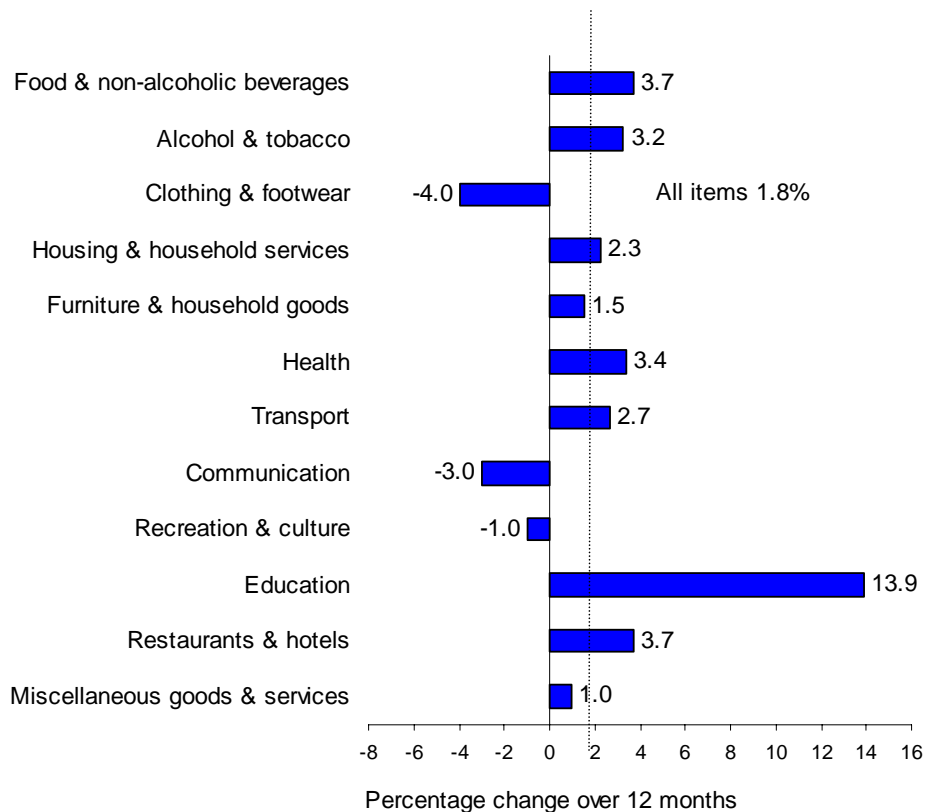
Fares and other travel costs

CPI main contributions¹ to the change in the all items 12-month rate between August 2007 and September 2007 (Unchanged).

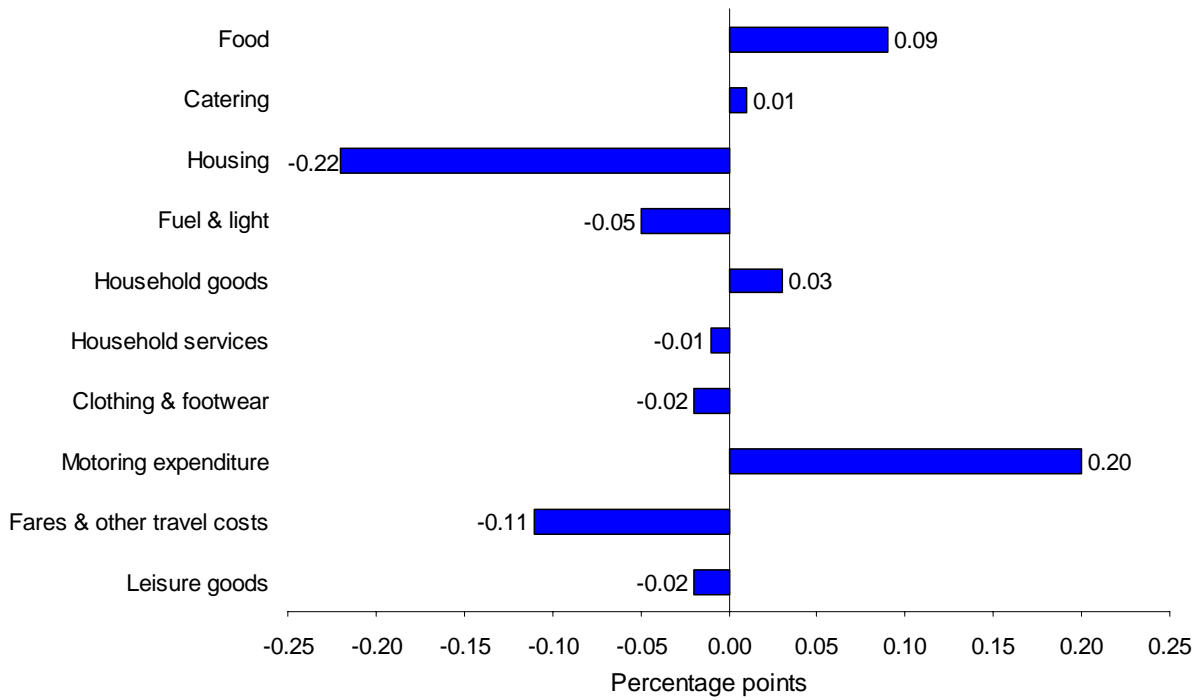


CPI comparison of the 12-month percentage changes

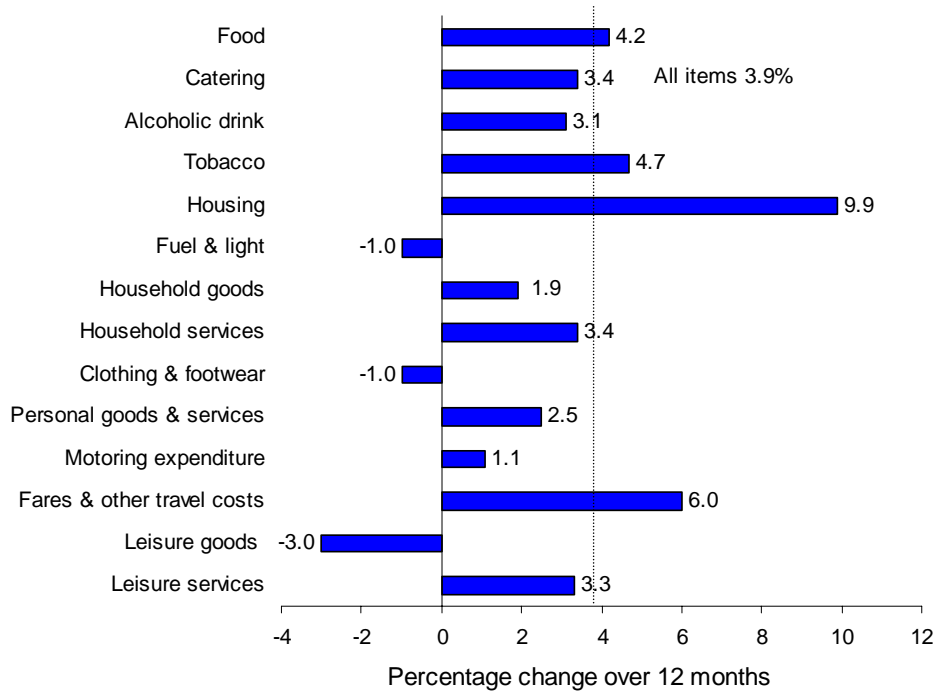

BACKGROUND NOTES

Relevance

- 1 The consumer prices index (CPI) is the main United Kingdom domestic measure of consumer price inflation for macroeconomic purposes. It forms the basis for the Government's inflation target that the Bank of England's Monetary Policy Committee (MPC) is required to achieve.
- 2 Internationally, the CPI is known as the Harmonised Index of Consumer Prices (HICP). HICPs are calculated in each Member State of the European Union, according to rules specified in a series of European Regulations developed by Eurostat in conjunction with the EU Member States. HICPs are used to compare inflation rates across the European Union. Since January 1999 it has also been used by the European Central Bank (ECB) as the measure of price stability across the euro area.
- 3 The retail prices index (RPI) is the most long-standing general purpose measure of inflation in the United Kingdom and is available from June 1947. It is used for a variety of purposes by both government and external users including the indexation of various incomes and prices and the uprating of pensions, benefits and index-linked gilts.

Methodology

- 4 The CPI and the RPI are compiled using the same underlying price data, based on a large and representative selection of around 650 individual goods and services for which price movements are measured in around 150 randomly selected areas throughout the UK. Around 120,000 separate price quotations are used every month to compile the indices. The outlets in which the prices are collected are selected randomly. Expenditure weights are held constant for one year at a time.
- 5 The selection of goods and services that are priced to compile the CPI and RPI is reviewed annually. The contents of the 2007 basket are described in an article published on the National Statistics website at:

- 6 Rates of change for the CPI are calculated from unrounded index levels, rather than on the published indices, which are rounded to one decimal place. The use of unrounded indices increases the accuracy of the calculation. The unrounded index levels are available on request. By contrast, rates of change for the RPI are calculated from the published rounded indices.

Reliability

- 7 Once the RPI indices are published they are never revised. CPI indices are revisable although past revisions have been minimal with the exception of those arising from re-referencing of the CPI to 2005=100, which took place with the publication of the January 2006 indices.

Comparability

- 8 The CPI's coverage of goods and services was extended in stages in the areas of health, education, childcare and insurance, with effect from the January 2000, 2001, and 2002 indices. In 2000, there was also a change to the population basis for the weights which was broadened from private households to include expenditure by foreign visitors and residents of institutional households. Coherence

- 11 The CPI and RPI both measure the average change from month to month in the prices of consumer goods and services purchased in the UK. However, they differ in both coverage and methodology. A detailed description of these differences is given in an article entitled "The New Inflation Target: the Statistical Perspective":
www.statistics.gov.uk/StatBase/Product.asp?vlnk=10913. The differences are summarised below:
- In the CPI, the geometric mean is used to combine the individual prices into elementary indices at the most basic level whereas the RPI uses arithmetic means.
 - The CPI excludes a number of RPI series mainly relating to housing costs (for example, council tax), and in particular to owner occupiers' housing costs (including mortgage interest payments, house depreciation and buildings insurance). In addition, the CPI excludes the annual road fund licence and, from 2006, TV licences which are classified as taxes in the UK National Accounts, and Trades Union subscriptions which by convention are not part of household expenditure.
 - The CPI includes series for university accommodation fees, foreign students' university tuition fees, and unit trust and stockbrokers' charges, none of which are included in the RPI.

- The CPI is categorised according to the international classification system, COICOP (Classification Of Individual CONsumption by Purpose). The way in which this maps to the RPI groupings is shown in the following table:

- The index for the purchase of new cars in the CPI is quality adjusted and based on actual published prices for new cars. New car prices in the RPI are imputed from movements in second hand car prices.
- The CPI weights are based on expenditure by all private households, foreign visitors to the UK and residents of institutional households. In the RPI, weights are based on expenditure by private households only, excluding the highest income households and pensioner households mainly dependent on state benefits.
- In the construction of the CPI weights, amounts paid out in insurance claims are distributed among the COICOP headings according to the nature of the claims' expenditure, with the residual (the service charge) being allocated to the relevant insurance heading. For the RPI weights, total expenditure (that is, gross of claims paid out) is assigned to the relevant insurance heading.

- 12 A breakdown of the difference between the CPI and RPI annual rates of inflation is shown in Table 10 of the CPI First Release.

Accessibility

- 13 This release includes the September 2007 data, collected on 18 September. Future publication dates are 13 November, 18 December, 15 January 2008, 12 February, 18 March and 15 April. The European Commission (Eurostat) will release figures for the harmonised index of consumer prices (HICP) for the month of September 2007 for EU member states excluding the UK, together with an EU average, on 16 October 2007. CPI RPI and Other Related Indices

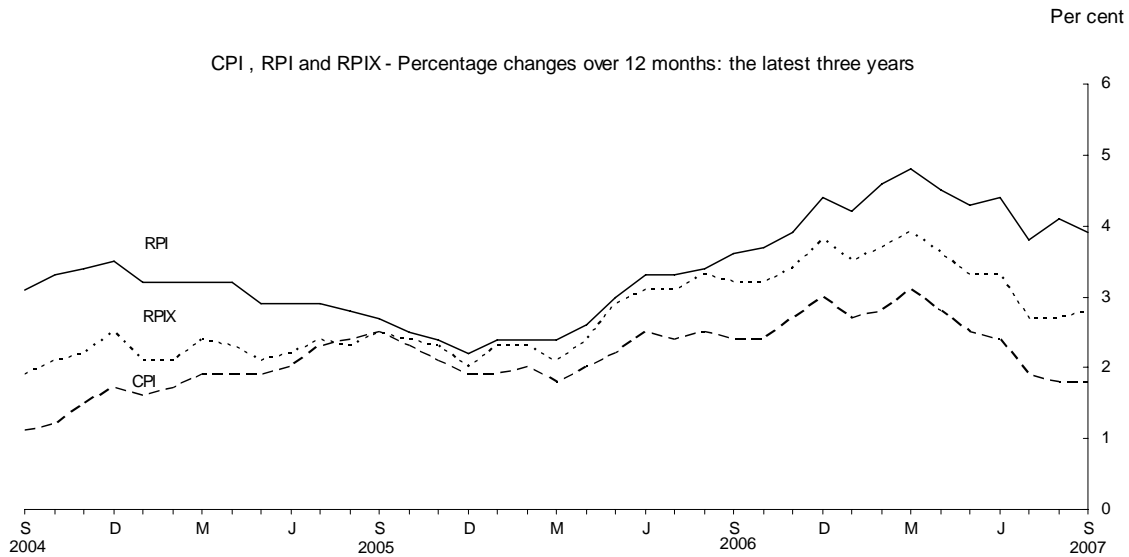


Chart for Table 6 – September 2007
CPI Goods and Services

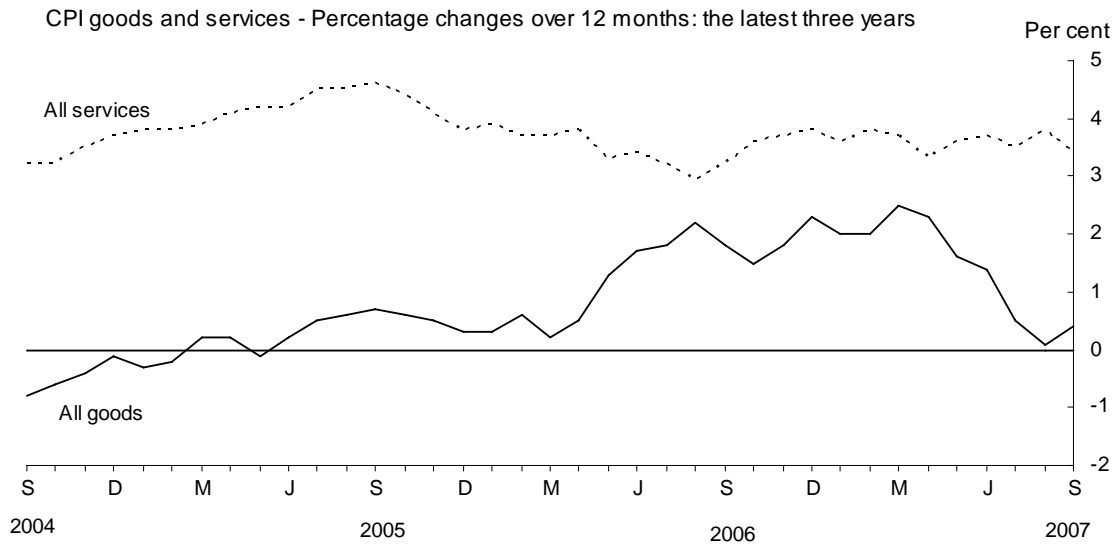
